

THE NEW HAMPSHIRE LOTTERY COMMISSION® NEW ENGLAND PATRIOTS™ 2021 SCRATCH GAME TICKETS SECOND-CHANCE DRAWING RULES

Players may send any non-winning ticket for the \$5 PATRIOTS™ Instant Scratch Game (game number 1532) to be entered in one (1) of three (3) drawings as detailed below.

- 1. Any non-winning ticket for the \$5 PATRIOTS™ Instant Scratch Game (game number 1532) may be entered for one (1) of three (3) drawings as detailed below.
- 2. To be eligible, the ticket must:
 - Be a non-winning ticket (does not contain any winnable prizes);
 - Have the entrant's name, mailing address, and daytime phone number legibly printed in the space provided on the back of the ticket. A mailing label is also acceptable;
 - Be signed by the entrant in the space provided on the back of the ticket;
 - Not be creased, folded or otherwise damaged, or altered in any way to give it an unfair advantage in the drawings. Note, multiple entries may be submitted in the same envelope; and
 - Be submitted to the New Hampshire Lottery Commission (the Commission) headquarters, prior to the Entry Deadline, at the following address:

- 3. Any ticket that is damaged, does not completely and clearly identify the entrant's contact details, or has not been signed by the entrant will be discarded. The Commission shall not be held responsible for entry errors by entrants.
- 4. There will be three (3) drawings total held at the Commission headquarters. Each drawing will be announced at least thirty (30) days in advance of the Entry Deadline. Drawings will be determined based on ticket sales.
- 5. Tickets received after the Entry Deadline will be entered into the next available drawing; tickets received after the last drawing date will be set aside for destruction.

- 6. Entries are good for one drawing only. Tickets not drawn for a prize at any drawing will be removed for destruction prior to any subsequent drawing.
- 7. For each of the three (3) second chance drawings, the prizes will be awarded in the following order:
 - a. Season Ticket package with VIP Parking Pass and Pavilion Hospitality Season Pass (1 winner)
 - b. Super Suite Home Game Package with Standard Parking Pass (5 winners)

- c. Upper Bowl Home Game Package with Standard Parking and Tailgate Pass (12 winners)
- 8. All game tickets awarded will be for games held during the 2022 NFL Season.
- 9. The Season Tickets package is comprised of:
 - Two (2) game tickets for each 2022 preseason and regular season home game;
 - Two (2) Pavilion Hospitality season passes; and
 - One (1) VIP season parking pass.
- 10. The 2022 Super Suite Home Game Package is comprised of:
 - Two (2) Super Suite home game tickets inclusive of food and non-alcoholic beverage; and
 - One (1) parking pass.
- 11. The Upper Bowl Home Game Package is comprised of:
 - Two (2) Upper Bowl home game tickets;
 - Two (2) Tailgate Party Passes; and
 - One (1) parking pass.
- 12. At the conclusion of each drawing described in four (4) above, five (5) alternate tickets will be drawn.
- 13. No person may win more than one (1) prize per drawing date. In the event that two or more tickets are drawn with the same entrant's name, only the first ticket drawn will be eligible to win a prize; the subsequent ticket(s) will be discarded and another will be drawn in its place.
- 14. \$5 PATRIOTS™ Instant Scratch Game may continue to be sold after the final drawing.
- 15. Federal taxes estimated at 24% of the value of each package that is valued at \$600 or greater will be borne by the Commission. The Commission's vendor, MDi, will send winners IRS Form W-2G in January of the year following the respective usage of the awarded prize. Any other taxes or fees will be responsibility of the prize winners.
- 16. The prizes will be as described above and there will be no substitution by cash.
- 17. Game tickets will be for games determined by the New England Patriots only and cannot be exchanged for different games.
- 18. Winners will be notified by mail, e-mail or telephone, using the contact information on the drawn tickets, and claim form. Prizes will be dispatched by The New England Patriots to the Commission for distribution. Prizes sent to winners from the Commission will be through a digital platform. Tickets to all events at Gillette Stadium will be mobile tickets. Winners can utilize their mobile tickets via the Gillette Stadium App, which is available on the App Store and Google Play.
- 19. To claim a prize, each winner shall complete a Commission Prize Claim Form and return same within thirty (30) days of the forms being mailed from the Commission. Failure to comply will result in the prize package being forfeited and the prize will be awarded to the first available alternate winner.
- 20. The Commission reserves the right to amend the drawing rules as necessary without prior notice no less than ten (10) days before any drawing.
- 21. The Commission offers no warrantees or guarantees of product quality and that availability and quality of the prize and its conformance to advertised representations is the sole responsibility of the promotional partner.

- 22. All prize packages may be subject to the rules, regulations, and restrictions imposed by the New England Patriots, the NFL, Gillette Stadium and any associated entities. Winners agree to abide by any and all rules and restrictions associated with the prize packages
- 23. The Commission shall not be responsible for injury or loss of life resulting from any prize awarded.
- 24. Participants release and hold harmless the Commission and its agents and employees from any liability arising out of participation in the drawings. The Commission is not responsible for any negligence of any person, or any claim, liability, injury, property loss, or other loss to participants or their companions arising from or in connection with any event or occurrence related to these drawing.
- 25. Employees of the Commission, their vendors and advertising company and immediate family members of the same household are prohibited from participating in any Patriots second chance drawing.
- 26. The Commission, at their sole discretion, may disqualify an entry, winner, or designee from participating in any aspect of the drawing if they deem or suspect that such person has engaged in or has attempted to engage in any of the following:
 - Act in violation of these Official Rules, Terms of Use, or Privacy Statement;
 - Act with intent to annoy, harass or abuse any other person;
 - Behave in any unsportsmanlike, inappropriate, uncooperative, disruptive, fraudulent, potentially fraudulent, or unusual behavior or activity; or
 - Participate in any activity deemed to be generally inconsistent with the intended operation of the drawing.

The Commission reserves the right to prosecute and seek damages from any such individual to the fullest extent of the law.

27. CHILD SUPPORT INTERCEPT — Pursuant to RSA 284:21-v, the Commission is required to review all lottery prize claims subject to federal tax reporting with a child support database provided by the Department of Health and Human Services (DHHS). In the event that a winner of any prize package described above owes child support, the winner shall have up to 21 days from the draw date to settle the total arrearage due as determined by DHHS to the DHHS, after which settlement the winner will be awarded the prize. Failure to settle any arrearage shall result in that winner's prize package being forfeit and the package will be issued to the first available alternate winner. The original winner(s) owing Child Support shall receive no other prize or compensation from the Commission relating to this game.
