## Official Rules

Promotion Name: **Tri-State Ultimate WAREHOUSE DASH® Second Chance Drawing**

### OFFICIAL RULES

- From **Wednesday, August 23, 2023, at 12:00:00AM – Sunday, May 26, 2024, at 11:59:59 PM** (the "Promotional Period"), any non-winning and active (meaning it is still eligible for cashing at retail) qualifying \$10 Ultimate Da\$h™ scratch tickets (Game #1604) may be used to enter the **Tri-State Ultimate WAREHOUSE DASH® Second Chance Drawing** ("Promotion").
- Ticket(s) eligible for entry are subject to change at the discretion of the New Hampshire Lottery.
- For every dollar spent on a non-winning game ticket(s) that a player submits, the player will be awarded 1 entry into the drawing. The non-winning eligible ticket and the resulting entries awarded are \$1: 1 entry.
  - For example, a \$10 non-winning Ultimate Da\$h™ (#1604) scratch ticket, will equal ten (10) entries.
- Entry is limited to twenty-five (25) total physical tickets per person per Second Chance drawing per day (24-hour period defined as 12:00:00 AM – 11:59:59 PM).
  - For example, one \$10 non-winning Ultimate Da\$h™ (#1604) scratch ticket will count as one (1) submission towards the twenty-five (25) physical ticket daily limit.
- Once the ticket entry is accepted through My603Rewards, the same ticket information will not be accepted a second time for the duration of the Promotion.
- \$10 Ultimate Da\$h™ scratch tickets purchased from a state other than New Hampshire are ineligible for entry into the New Hampshire Promotion.
- A player does not need to retain the game ticket(s) submitted as proof of eligibility to claim their prize if selected as the winner.
- A total of three (3) drawings will be conducted. Five (5) Second Chance Drawing New Hampshire winners will be selected over the three (3) drawings. Each drawing will be announced at least thirty (30) days in advance of the Entry Deadline. Entry Deadlines and Draw Dates will be determined based on ticket sales.
  - Drawing one, two (2) winners will be drawn
  - Drawing two, two (2) winners will be drawn
  - Drawing three, one (1) winner will be drawn
- A player can only win one (1) prize
- The final verified drawing results will be posted to the website and the mobile app, on (or around) a week after the drawing has occurred.

To be eligible, a player must have a My603Rewards account via the NH Lottery mobile app. Tickets must be entered online through their My603Rewards account on the NH Lottery mobile app, which is located in both the Apple and Android application stores. Deadline for entry is **Sunday, May 26, 2024, at 11:59:59 PM** to participate in the drawings.

## Tri-State Ultimate WAREHOUSE DASH® Second Chance Drawing

Existing My603Rewards or New Hampshire iLottery account holders can log in through the mobile application. New participants must register for a My603Rewards or login using their New Hampshire iLottery account credentials through the mobile application. By successfully transmitting a completed online entry on the mobile app with the appropriate information as directed underneath the \$10 Tri-State Ultimate WAREHOUSE DASH® Second Chance Drawing screen, each participant or each eligible ticket will be entered into the Promotion.

Entries of game ticket serial numbers determined to be in an expired, stolen or not part of a valid sold or promotional inventory status are not eligible.

All information submitted online by entrants is subject to, and will be treated in a manner consistent with, the New Hampshire Lottery Commission's (hereinafter, "the Lottery") Privacy Policy, which is currently accessible at: <https://www.nhlottery.com/Privacy-Policy>. The Lottery, at its discretion, reserves the right to select and/or change the prize(s) to be awarded as part of this Promotion. Entrants must be a US Person, 18 years of age or older. Void where prohibited or restricted by law.

### **The Tri-State Ultimate WAREHOUSE DASH® prize is as follows:**

Each Prizewinner will receive a 3-day, 2-night stay for themselves and one (1) guest at the Hyatt Place Portland-Old Port in Portland, Maine. The Prizewinner and guest will participate in the Tri-State Ultimate WAREHOUSE DASH® Event to collect merchandise items for ninety seconds (:90), with the chance to collect \$1 million.

Federal taxes estimated at 24% of the value of the Prize package and merchandise picked will be borne by the Lottery Commission, with the exception of the \$1 million prize. If a Prizewinner collects the \$1 million prize, they are responsible for paying the 24% federal taxes for that part of the total prize. The Lottery Commission's vendor, Scientific Games or MDI, will send winners IRS Forms W-2G in January of the year following the respective usage of the awarded prize. Additionally, any other taxes or fees not expressly noted, will be the responsibility of the Prizewinner.

### **The Tri-State Ultimate WAREHOUSE DASH® Event Weekend is as follows:**

The Tri-State Ultimate WAREHOUSE DASH® Event will consist of thirteen (13) 2-person teams. Each state will have the below number of Teams:

- Maine- five (5) teams
- New Hampshire- five (5) teams
- Vermont- three (3) teams

Teams will be invited for a 2-night, 3-day stay at Hyatt Place Portland-Old Port in Portland, Maine from Friday, September 27, 2024, to Sunday, September 29, 2024. A dinner for all teams and lottery/event personnel will take place on Friday, September 27, 2024, at DiMillo's On The Water in Portland. The Tri-State Ultimate WAREHOUSE DASH® Event will take place at the Forefront Brick South in Portland on Saturday, September 28, 2024. Departure will be on Sunday, September 29, 2024.

Each team consists of one Second Chance Prizewinner and the Prizewinner's one guest. The Prizewinner's guest will assist the Prizewinner in the event course. Each team will be supplied with a minimum of one (1) empty cart.

One team member will be the dedicated "pusher," and the other team member will be the dedicated "picker." Please note, the "pusher" can rearrange items in the cart but may NOT pull items from the shelves. Any item pulled, picked, or otherwise removed from the shelves by the "pusher" shall not be included as a "picked" item, and shall not be included in the prizes won or awarded during the dash event unless "picker" pulls the item and places the item in the cart.

Each team will have thirty (30) minutes before the dash event to walk aisles designated as the "Tri-State Ultimate WAREHOUSE DASH® Event" course and to develop their plan for which merchandise items they wish to select.

Merchandise is available only from the aisles designated as the "Tri-State Ultimate WAREHOUSE DASH® Event" course. Any other warehouse area is considered outside of the event course and is not available for selection. Marking or tagging of the merchandise, floor, racking, etc., before the start of the Dash Event is not allowed.

A team member may only select a single (1) quantity of each merchandise item. If more than one (1) of a merchandise item is grabbed, the extras will be returned to the shelf.

One of the boxes displayed in an aisle contains a \$1 million prize that may be won if selected by a picker. That prize is a cash amount, subject to 24% federal tax withholding and any other applicable taxes. Each team has the chance win a \$1 million prize and the odds of picking the \$1 million dollar prize are 1:1,000.

Only one team (consisting of the pusher and picker) will be on the "Tri-State Ultimate WAREHOUSE DASH® Event" course at a time. When the team is ready, an air horn will sound to alert the team that they may begin and stop watches will start with ninety seconds (:90) on the clock. The team may begin to dash up and down the aisle(s) putting as much merchandise into the cart(s) as possible.

Referees will be stationed throughout the dash event course with stopwatches to alert the team of their remaining dash event time. When the team's ninety seconds (:90) is up, a referee will inform them, and another air horn will sound to alert the team to stop. At this time, no more items can be "picked."

The team will then take their cart(s) to the designated area where all merchandise items selected will be verified immediately.

The Prizewinner shall be allowed to keep all merchandise items the “picker” placed in their cart (the “Tri-State Ultimate WAREHOUSE DASH® Event Prizes”).

All items will be restocked on the shelves after each team finishes ensuring every team has the same chance to pick all items.

Each Prizewinner will be provided a list of their dash event prizes for review prior to their departure from the warehouse. The Tri-State Ultimate WAREHOUSE DASH® Event prizes will be shipped to each Prizewinner within twenty (20) business days following the event. ## **RANDOM NUMBER GENERATOR DRAWING AND RESULTS:**

The actual drawing dates will be determined by the Lottery personnel, at the direction of the Executive Director, and the final, verified drawing results will be posted to the mobile application on (or around) a week after the drawing has occurred. The Prizewinner will be randomly selected from among all eligible entries received for each drawing. Subject to verification of eligibility and compliance with these Official Rules, the potential winner will be declared the official winners of this Promotion. There will be three (3) drawings, with a total of five (5) Prizewinners.

### How do I know if my ticket is eligible?

## **Am I responsible for any taxes on these prizes?**

## **Can I enter the drawing more than one time?**

Yes. You can enter up to twenty-five (25) eligible physical tickets per day (24-hour period from 12:00:00 AM – 11:59:59 PM). Registered users will receive ten (10) entries for each eligible \$10 Ultimate Da\$h™ (#1604) scratch ticket scanned. For example, a \$10 non-winning Ultimate Da\$h™ (#1604) scratch ticket, will equal ten (10) entries.

A player may only win one (1) prize.

## **Do I need to keep my tickets after submitting them into the drawings?**

No, you are not required to keep your tickets.

## **Can I mail in my entries?**

No, only entries via the NH Lottery mobile app are allowed.
