### **ENTRY DETAILS:**

- From Wednesday, August 21, 2024 to TBD (the "Promotional Period"), any non-winning and active (subject to change) qualifying \$5 Patriots™ (#1637) scratch ticket may be used to enter the Patriots™ Second Chance Drawing ("Promotion").
  - Ticket(s) that are eligible for entry are subject to change at the discretion of the New Hampshire Lottery.
- For every non-winning \$5 Patriots™ (#1637) ticket(s) a player submits, the player will be awarded 5 entries into the drawing. The non-winning eligible ticket and the resulting entries awarded are 1 ticket: 5 entries.
  - For example, a \$5 non-winning Patriots™ (#1637) scratch ticket will equal five (5) entries.
- Ticket submission is limited to twenty-five (25) total physical tickets per person per day (24-hour period defined as 12:00:00 AM 11:59:59 PM).
  - For example, a \$5 non-winning Patriots™ (#1637) scratch ticket will count as one (1) of the twenty-five (25) total submissions.
- Entries are eligible for one drawing only. Tickets entered for Drawing 1 will not be entered into any further drawings. Once the ticket entry is accepted through My603Rewards, the same ticket information will not be accepted a second time.
- During the Second Chance Drawing period, non-winning tickets from this game are not eligible for My603Rewards points.
- Three (3) drawings will be conducted. Players are eligible to win a total of one (1) prize per
  drawing. The prizes will be as described (see **Schedule and Prize Details**) and there will be
  no substitution by cash. Game tickets will be for games determined by the New England
  Patriots only and cannot be exchanged for different games.
- When Entry Deadlines and Drawings are announced, they will be posted, at a minimum, on the Lottery website and the **Schedule and Prize Details** table above.
- Drawings will be announced no less than 30 days before the drawing takes place.
- The final verified drawing results will be posted to the website and the mobile app, on (or around) two (2) weeks after the drawing has occurred.
- A player does not need to retain the game ticket(s) submitted as proof of eligibility to claim their prize if selected as a winner.

### **ELIGIBILITY:**

To be eligible, a player must have a My603Rewards account via the NH Lottery mobile app, which is in both the Apple and Android application stores. Tickets must be entered online through their My603Rewards account.

Existing My603Rewards or New Hampshire iLottery account holders can log in through the mobile application. By successfully transmitting a completed online entry on the mobile app with the appropriate information as directed underneath the Patriots™ Second Chance Drawing screen, each eligible ticket will be entered into the Promotion.

Entries of game ticket serial numbers determined to be in an expired, stolen or not part of a valid sold or promotional inventory status are not eligible.

The actual drawing date will be determined by the Lottery personnel, at the direction of the Executive Director, and the final, verified drawing results will be posted to the mobile application on (or around) **two (2) weeks of each drawing being conducted**. The prize winners will be randomly selected from among all eligible entries received. Subject to verification of eligibility and compliance with these Official Rules, the potential winners will be declared the official winners of this Promotion.

The Lottery reserves the right to amend the drawing rules as necessary without prior notice no less than thirty (30) days before any drawing.

Winners will be notified by mail, e-mail or telephone, using the contact information the player used to register their My603Rewards account. Prizes will be dispatched by The New England Patriots to

the Lottery for distribution. Prizes sent to winners from the Lottery will be through a digital platform. **Tickets to all events at Gillette Stadium are mobile tickets. Gillette Stadium is a cashless venue.** Winners can utilize their mobile tickets via the Gillette Stadium App, which is available on the App Store and Google Play.

To claim a prize, each winner shall complete a Commission Prize Claim Form and return same within thirty (30) days of the forms being mailed from the Lottery. Failure to comply will result in the prize package being forfeited and the prize will be awarded to the first available alternate winner.

The Lottery offers no warranties or guarantees of product quality and that availability and quality of the prize and its conformance to advertised representations is the sole responsibility of the promotional partner.

The Lottery, at their sole discretion, may disqualify an entry, winner, or designee from participating in any aspect of the drawing if they deem or suspect that such person has engaged in or has attempted to engage in any of the following:

# What is the promotional period?

The promotion will run from Wednesday, August 21, 2024 – TBD. The promotional period for each drawing will run between the "Entry Start and Entry Deadline" dates as outlined in Schedule and Prize Details. Tickets must be entered by each Drawing's "Entry Deadline" date to be eligible for that drawing.

# What are the prizes for the Promotion?

## When will the Promotion drawing results be available?

The drawing will be conducted, and final verified drawing results will be posted to the mobile application, on (or around) two weeks after a determined drawing date (subject to change).

## Which tickets are eligible for the Promotion?

Any non-winning and active qualifying scratch tickets from \$5 Patriots™ (#1637) may be used to enter the Promotion (subject to change).

# How do I know if my ticket is eligible?

If you have a non-winning \$5 Patriots™ (#1637) that is active, that ticket is eligible for entry. Once you scan an eligible ticket within the New Hampshire Lottery app, a message will appear saying whether it is eligible.

## Am I responsible for any taxes on these prizes?

Yes. Any prize won via the Lottery that is valued at \$600 or greater is a taxable prize and will need to be filed with your federal tax return. Federal taxes estimated at 24% of the value of the prize package will be borne by the New Hampshire Lottery. The Lottery Commission's vendor, Scientific Games will send winners IRS Form W-2G in the January following the date of the game a winner attends. Any other taxes or fees not expressly noted, will be the responsibility of the Prizewinner.

# Can I enter a drawing more than one time?

Yes! Registered My603Rewards users will receive **one (1) entry for each dollar of an eligible non-winning scratch ticket scanned**. For example, one \$5 Patriots™ (#1637) scratch ticket will equal five (5) entries. Maximum 25 total physical ticket entries per day per drawing. Meaning a player may only enter 25 physical scratch tickets in a 24-hour period (defined as 12:00:00 AM – 11:59:59 PM).

## How many prizes may be won per drawing?

A player is eligible to win only one (1) prize per drawing.

### Do I need to keep my tickets after submitting them into the drawings?

No, you are not required to keep your tickets.

# Can I mail in my entries?

No, only entries via the NH Lottery mobile app are allowed.

### Are my non-winning \$5 Patriots™ (#1637) scratch tickets eligible for My603Rewards points?

No. During the Second Chance Draw period, eligible non-winning tickets may only be entered for the Second Chance Drawing. Once the deadline has passed for entry into the last drawing, tickets may be eligible for My603Rewards points.
