

## \$5 Big Country Cash Second Chance Drawing Rules

- Starting from Wednesday, February 23, 2022 at 12:00:00AM and ending on October 3, 2022 at 11:59 PM. Any of the following active non-winning qualifying New Hampshire Lottery Tickets may be used to enter the \$5 Big Country Cash Second Chance Drawing ("Promotion").
  - A non-winning ticket for the \$5 Big Country Cash instant scratch game (Game #1552)
- Ticket(s) that are eligible for entry are subject to change at the discretion of the New Hampshire Lottery.
- Only twenty-five (25) entries per person per day (12:00:00AM 11:59:59PM) are permitted.
- A player does not need to retain the game ticket(s) they submitted as proof of eligibility to claim their prize.
- Entries are good for one drawing only. For example, tickets entered for the first drawing are not eligible to win in subsequent drawing.
- There will be two (2) drawings total. Each drawing will be announced at least thirty (30) days in advance of the Entry Deadline. Entry Deadlines and Drawing dates will be determined based on ticket sales and timing of concert tour. The last top prize in this game has been claimed and at retail, sales will end on September 29, 2022.
- When Entry Deadlines and Drawings are announced, they will be posted, at a minimum, on the Lottery website and below:

To be eligible, a player must have a My603Rewards account via the NH Lottery mobile app. Tickets must be entered online through their My603Rewards account on the NH Lottery mobile app, which is located in both the Apple and Android application stores.

Existing My603Rewards or New Hampshire iLottery account holders can log in through the mobile application. New participants must register for a My603Rewards or login using their New Hampshire iLottery account credentials. By successfully transmitting a completed online entry on the mobile app with the appropriate information as directed underneath the \$5 Big Country Cash Second Chance Drawing screen, a participant's eligible ticket(s) will be entered into the Promotion.

Entries of game ticket serial numbers determined to be in an expired, stolen or missing inventory status or not part of a valid sold, activated or promotional inventory status are not eligible.

All information submitted online by entrants is subject to, and will be treated in a manner consistent with, the New Hampshire Lottery Commission's (hereinafter, "the Lottery") Privacy Policy, which is currently accessible at: https://www.nhlottery.com/Privacy-Policy. The Lottery, at its discretion, reserves the right to select and/or change the prize(s) to be awarded as part of this Promotion. Entrants must be legal residents of the United States who are 18 years of age or older. Void where prohibited or restricted by law.

All promotions are governed by and subject to New Hampshire Administrative Rules SW 6000 "Rules for Second Chance Drawings." ## **RANDOM NUMBER GENERATOR DRAWING AND RESULTS:**

The actual drawing dates will be determined by the Lottery personnel, at the direction of the Executive Director, and the final, verified drawing results will be posted, at a minimum, to the mobile application. The prize winners will be randomly selected from among all eligible entries received. Subject to verification of eligibility and compliance with these Official Rules, the potential winners will be declared the official winners of this Promotion. Two (2) drawings will be held. There will be one (1) winner for drawing 1 and two winners for drawing 2 for three (3) winners total.

The prize for Drawing #1 will likely occur in Fall 2022. Prizes for Drawings #2 will likely occur in Summer or Fall of 2023. Final tour dates to be determined. Each winner will receive:

ULTIMATE TOURING EXPERIENCE, a five-day, four-night trip for the Prizewinner or the Prizewinner's proxy ("Prizewinner") and one (1) guest will enjoy an exclusive once-in-a-lifetime experience on the road with an A-list country recording artist, based upon the artist's tour schedule. The all-inclusive package includes:

- Round trip coach air transportation to and from location to be determined based on artist's tour schedule, from any major Maine, New Hampshire, Massachusetts or Vermont commercial airport for winner and guest;
- Bus transportation with luxury bus for duration of trip. The bus offers many comforts of home but are not ADA\* approved. The facilities are a communal environment with separate sleeping bunks;
- Access to hotel showers and restrooms at each stop;
- Three (3) meals per day for two (breakfast, lunch and dinner);
- Two (2) VIP passes to concert(s) (winners will typically enjoy 2 full shows);
- Two (2) backstage passes for each concert;
- One (1) group meet and greet with talent;
- Two (2) premium promotional concert giveaways;
- \$500 spending money payable as a Visa or MasterCard Debit Card and provided to each GRAND PRIZE TRIP Winner (and not to guest) at least two (2) weeks prior to the trip departure.

\*Within reason, the best efforts to accommodate any winner's special ADA needs or provide alternative travel arrangements, as necessary.

The odds of winning are dependent upon total entries into the \$5 Big Country Cash Second Chance Drawing promotion.

There is no cash option for this prize. GRAND PRIZE TRIP packages may be transferable from one GRAND PRIZE TRIP Winner to a third party one time as agreed by parties.

At the conclusion of each drawing described above, five (5) alternate tickets will be drawn.

## **GENERAL:**

All prize details, including without limitation, shall be determined in the sole and absolute discretion of the Lottery. Employees, officers or directors of the Lottery, including its affiliates, subsidiaries, advertising and promotion agencies, suppliers, or any relative or spouse of such an employee, officer or director, living as a member in such employee, officer or director's household, are not eligible to enter this Promotion. Void where prohibited by law.

\$5 Big Country Cash (#1552) instant scratch game may continue to be sold after the final drawing.

Federal taxes estimated at 24% of the value of each package that is valued at \$600 or greater will be borne by the Lottery Commission. The Lottery Commission's vendor, Alchemy 3, will send winners IRS Forms W-2G in January of the year following the respective usage of the awarded prize. Any other taxes or fees will be responsibility of the prize winner.

Winners will be notified by mail. Secondarily, the Lottery may contact further by e-mail or telephone, using the contact information as provided in second chance drawing accounts. To claim a prize, each

winner shall complete a Commission Prize Claim Form and additional information and return same within thirty (30) days of the forms being mailed from the Commission. Failure to comply will result in the prize package being forfeited and the prize will be awarded to the first available alternate winner.

Acceptance of the prize constitutes permission for the Lottery and their agencies to use the prize winner's name and/or likeness worldwide, in perpetuity, for purposes of advertising and trade without further compensation, notification or permission unless prohibited by law, in any and all media now known or hereafter devised. ALCHEMY 3, the Lottery Commission's vendor, will initiate the GRAND PRIZE TRIP package fulfillment process. ALCHEMY 3 shall contact each GRAND PRIZE TRIP Winner within ten (10) business days of completed prize claim to begin making travel arrangements. Each GRAND PRIZE TRIP Winner must confirm their trip within ten (10) days of ALCHEMY 3's contact.

The Commission reserves the right to amend the drawing rules as necessary without prior notice no less than ten (10) days before any drawing.

The Commission offers no warrantees or guarantees of product quality and that availability and quality of the prize and its conformance to advertised representations is the sole responsibility of the promotional partner, Gig Tours.

All prize packages may be subject to the rules, regulations, and restrictions imposed by GIG TOURS and any associated entities. Winners agree to abide by any and all rules and restrictions associated with the prize packages.

The Commission shall not be responsible for injury or loss of life resulting from any prize awarded.

Participants release and hold harmless the Commission and its agents and employees from any liability arising out of participation in the drawings. The Commission is not responsible for any negligence of any person, or any claim, liability, injury, property loss, or other loss to participants or their companions arising from or in connection with any event or occurrence related to these drawing.

The Commission, at their sole discretion, may disqualify an entry, winner, or designee from participating in any aspect of the drawing if they deem or suspect that such person has engaged in or has attempted to engage in any of the following:

- Act in violation of these Official Rules, Terms of Use, or Privacy Statement;
- Act with intent to annoy, harass or abuse any other person;
- Behave in any unsportsmanlike, inappropriate, uncooperative, disruptive, fraudulent, potentially fraudulent, or unusual behavior or activity; or
- Participate in any activity deemed to be generally inconsistent with the intended operation of the drawing.

The Commission reserves the right to prosecute and seek damages from any such individual to the fullest extent of the law.

CHILD SUPPORT INTERCEPT – Pursuant to RSA 284:21-v, the Commission is required to review all lottery prize claims subject to federal tax reporting with a child support database provided by the Department

of Health and Human Services (DHHS). In the event that a winner of any prize package described above owes child support, the winner shall have up to 21 days from the draw date to settle the total arrearage due as determined by DHHS to the DHHS, after which settlement the winner will be awarded the prize. Failure to settle any arrearage shall result in that winner's prize package being forfeit and the package will be issued to the first available alternate winner. The original winner(s) owing Child Support shall receive no other prize or compensation from the Commission relating to this game.
