

TRI-STATE GOLDEN SPIN SECOND CHANCE DRAWING

Official Rules for the Tri-State Golden Spin Second Chance Drawing

PRIZE DETAILS:

Prizewinners and their guest will join winners from the Vermont and Maine Lotteries June 23-26, 2025 for a trip to the Golden Nugget Las Vegas Hotel & Casino in Las Vegas, Nevada.

The Tri-State Golden Spin Prize Pack includes:

- Participation in the Tri-State Golden Spin event at the Golden Nugget Las Vegas Hotel & Casino in Las Vegas, Nevada where winners will get to Spin to Win for the chance to win up to \$250,000!
- Roundtrip coach airfare for up to two (2) people from any U.S. International airport to Harry Reid International Airport in Las Vegas, Nevada (inclusive of all associated security fees, taxes, and surcharges).
 - **A Real ID or passport will be required to fly after May 7th, 2025.**
- Ground transfers between Harry Reid International Airport and the destination hotel.
- One (1) Spa Suite Bedroom at the Golden Nugget Las Vegas Hotel & Casino in Las Vegas, Nevada for three (3) nights.
- One five-hundred-dollar (\$500) gift card to Landry's restaurants, for meals during the trip to be provided two (2) weeks prior to the scheduled trip departure date.
- One thousand dollars (\$1,000) spending money for the Prizewinner to be provided two (2) weeks prior to the scheduled trip departure date.
- Five hundred dollars (\$500) in Golden Nugget gaming chips.

If a selected winner is unable to claim the prize or does not do so within thirty (30) days of notification of winning, it will be awarded to the next eligible alternate. The odds of winning are dependent upon total entries into the Promotion.

ENTRY DETAILS:

- From **Wednesday, May 1, 2024, at 12:00:00AM – Sunday, March 30, 2025, at 11:59:59PM** (the "Promotional Period"), any non-winning and active (qualifying **\$10 THE GOLDEN \$PIN (#1635)** scratch ticket may be used to enter the **Tri-State Golden Spin Second Chance Drawing** ("Promotion").
 - Drawing 1 Entry – May 1, 2024 through September 8, 2024 at 11:59:59pm
 - Drawing 2 Entry – September 9, 2024, at 12:00:00AM – March 30, 2025, at 11:59:59PM
 - Ticket(s) eligible for entry are subject to change at the discretion of the New Hampshire Lottery.
 - Active meaning it is still eligible for cashing at retail.
- For every dollar spent on a non-winning game ticket(s) that a player submits, the player will be awarded one (1) entry into the drawing. The non-winning eligible ticket and the resulting entries awarded are \$1: 1 entry.
 - For example, a non-winning \$10 The Golden \$pin (#1635) scratch ticket, will equal ten (10) entries.

- Entry is limited to twenty-five (25) total physical tickets per person per day (24-hour period defined as 12:00:00 AM – 11:59:59 PM).
 - For example, a \$10 non-winning The Golden \$pin (#1635) scratch ticket will count as one (1) ticket towards the twenty-five (25) physical ticket daily limit.
- Once the ticket entry is accepted through My603Rewards, the same ticket information will not be accepted a second time for the duration of the Promotion.
- During the Second Chance Drawing period, non-winning tickets from this game are not eligible for My603Rewards points.
- A player does not need to retain the game ticket(s) submitted as proof of eligibility to claim their prize if selected as a winner.
- Two (2) drawings will be conducted. From all eligible players, the prizes will be awarded as follows:

- The final verified drawing results will be posted to NH Lottery mobile app, on (or around):
 - Within two weeks of Drawing 1
 - Within two weeks of Drawing 2
- A player can only win one (1) prize total. Meaning, the winner of Drawing 1 is not eligible to win in Drawing 2.

ELIGIBILITY:

To be eligible, a player must have a My603Rewards account via the NH Lottery mobile app. Tickets must be entered online through their My603Rewards account on the NH Lottery mobile app, which is in both the Apple and Android application stores.

Existing My603Rewards or New Hampshire iLottery account holders can log in through the mobile application. New participants must register for a My603Rewards or login using their New Hampshire iLottery account credentials through the mobile application. By successfully transmitting a completed online entry on the mobile app with the appropriate information as directed underneath the Tri-State Golden Spin Second Chance Drawing screen, each eligible ticket will be entered into the Promotion.

Entries of game ticket serial numbers determined to be in an expired, stolen or not part of a valid sold or promotional inventory status are not eligible.

All information submitted online by entrants is subject to, and will be treated in a manner consistent with, the New Hampshire Lottery Commission's (hereinafter, "the Lottery") Privacy Policy, which is currently accessible at: <https://www.nhlottery.com/Privacy-Policy>. The actual drawing date will be determined by the Lottery personnel, at the direction of the Executive Director, and the final, verified drawing results will be posted to the mobile application on (or around) **two (2) weeks of Drawing 1 and two (2) weeks of Drawing 2, subject to change**. The prize winners will be randomly selected from among all eligible entries received. Subject to verification of eligibility and compliance with these Official Rules, the potential winners will be declared the official winners of this Promotion.

FAQs

What is the promotional period?

The promotional period runs from **Wednesday, May 1, 2024, at 12:00:00AM through Sunday, March 30, 2025 at 11:59:59PM.**

- Tickets entered from Wednesday, May 1, 2024, at 12:00:00AM – September 8, 2024, at 11:59:59PM are eligible for Drawing 1. All entries received will be discarded after the drawing date and will not be eligible for Drawing 2.
- Tickets entered from September 9, 2024 at 12:00:00AM – March 30, 2025 at 11:59:59PM are eligible for Drawing 2.

When is the deadline to enter my ticket(s)?

All tickets must be entered by the following dates to be eligible for this promotion.

- All Tickets for Drawing 1 must be entered by September 8, 2024 at 11:59:59PM to be eligible for Drawing 1.
- Tickets for Drawing 2 must be entered by Sunday, March 30, 2025 at 11:59:59PM to be eligible for Drawing 2.

What are the prizes for the Promotion?

Two (2) winners will receive the Tri-State Golden Spin Prize Pack. Please see the Prizes & Drawing section of the rules for more information.

When will the Promotion drawing results be available?

The drawing will be conducted, and final verified drawing results will be posted to the mobile application, on (or around) two weeks after a determined drawing date (subject to change).

Which tickets are eligible for the Promotion?

Any non-winning and active qualifying scratch tickets from (#1635) \$10 The Golden \$pin may be used to enter the Promotion (subject to change).

How do I know if my ticket is eligible?

If you have a non-winning \$10 The Golden \$pin (#1635) that is active that ticket is eligible for entry. Once you scan an eligible ticket within the New Hampshire Lottery app, a message will appear saying whether it is eligible.

Am I responsible for any taxes on these prizes?

Yes. Any prize won via the Lottery that is valued at \$600 or greater is a taxable prize and will need to be filed with your federal tax return. Federal taxes estimated at 24% of the value of the prize package, will be borne by the Lottery Commission, excluding cash prize wins from the Tri-State Golden Spin event. The Lottery Commission's vendor, Alchemy 3, will send winners IRS Forms W-2G in January 2026. Prize money won during the Spin to Win promotion will be awarded by the New Hampshire Lottery. Following the event, prize checks will be sent to each winner, minus the 24% withheld for Federal Taxes. The New Hampshire Lottery will send each winner, IRS Form W-2G in January 2026.

Can I enter the drawing more than one time?

Yes! Registered My603Rewards users will receive **one (1) entry for each dollar of an eligible non-winning scratch ticket scanned**. For example, one \$10 non-winning The Golden \$pin (#1635) scratch ticket will equal ten (10) entries.

Maximum 25 total physical ticket entries per day per Promotion. Meaning a player may only enter 25 physical scratch tickets in a 24-hour period (defined as 12:00:00 AM – 11:59:59 PM).

A player can only win one (1) prize. The winner from drawing 1 will be ineligible to win drawing 2.

Do I need to keep my tickets after submitting them into the drawings?

No, you are not required to keep your tickets.

Can I mail in my entries?

No, only entries via the NH Lottery mobile app are allowed.

Are my non-winning \$10 The Golden \$pin (#1635) eligible for My603Rewards points?

No. During the Second Chance Draw period, eligible non-winning tickets may only be entered for the Second Chance Drawing. Once the deadline has passed for entry into the last drawing, tickets may be eligible for My603Rewards points.
