## OFFICIAL RULES

- From **Wednesday, March 29, 2023 at 12:00:00AM – TBD** (the "Promotional Period"), any non-winning and active (meaning it is still eligible for cashing at retail) qualifying \$20 Double Your Million scratch tickets (#1591) may be used to enter the **Double Your Million Second Chance Drawing** ("Promotion"). Ticket(s) eligible for entry are subject to change at the discretion of the New Hampshire Lottery.
- **NEW!! Drawing 1 and Drawing 2:** Two additional promotional drawings will be held leading up to Drawing 3 (Grand Prize).
  - All players who have submitted at least one entry for Drawing 3 (Grand Prize) will be eligible to win. Any player who has entered a qualifying \$20 Double Your Million scratch ticket (#1591) will automatically be entered into Drawing 1 and Drawing 2. Entry to Drawing 1 and Drawing 2 is based on the entrant, not the number of entries; there is one entry per player, regardless of total entries.
  - For example, should a player submit 30 tickets towards Drawing 3 (Grand Prize), they will be given one (1) entry for both Drawing 1 and Drawing 2. Players who win Drawing 1 and/or Drawing 2 are still eligible to win the Grand Prize in Drawing 3.
  - Entries will not be discarded between drawings – all entries into the Promotion are eligible for the Grand Prize Drawing. Two Drawings will be conducted to randomly

award one winner from each Drawing with \$10,000 before Federal Withholding Taxes. Drawings will be announced at least 30 days ahead of the drawing.

- The Prize multiplier is not applicable to the Prize for Drawings 1 and 2.
- All Lottery rules and regulations regarding Second Chance Drawings apply to the additional Drawings.
- **Drawing 3 (Grand Prize):** For every non-winning \$20 Double Your Million scratch ticket (#1591) a player submits, the player will be awarded one (1) entry into the Drawing 3 (Grand Prize) drawing. The non-winning eligible ticket and the resulting entries awarded are 1 ticket: 1 entry.
  - For example, a \$20 non-winning Double Your Million (#1591) scratch ticket, will equal one (1) entry.
- Entry is limited to twenty-five (25) total tickets per person per day (24-hour period).
  - For example, a \$20 non-winning Double Your Million (#1591) scratch ticket will count as one (1) of the twenty-five (25) total entries.
- Once the ticket entry is accepted through My603Rewards, the same ticket information will not be accepted a second time for the duration of the Promotion. During the Second Chance Drawing period, non-winning tickets from this game are not eligible for My603Rewards points.
- Double Your Million scratch tickets purchased from a state other than New Hampshire are ineligible for entry into the Promotion and will be disqualified.
- A player does not need to retain the game ticket(s) submitted as proof of eligibility to claim their prize if selected as the winner.
- One (1) Grand Prize drawing will be conducted. The drawing will be announced at least thirty (30) days in advance of the Entry Deadline. The Entry Deadline and Draw Date will be determined based on ticket sales. From all eligible entries, one (1) winner will be drawn.
- The Grand Prize will be awarded as follows:
  - If a non-winning ticket with 1X in the multiplier box is entered into the Second Chance Drawing AND is the drawn winner of Drawing 3 (Grand Prize), the player will win \$1 million.
  - If a non-winning ticket with 2X in the multiplier box is entered into the Second Chance Drawing AND is the drawn winner of Drawing 3 (Grand Prize), the player will win \$2 million.
- The final verified drawing results will be posted to the website and the mobile app, on (or around) a week after each drawing has occurred.

To be eligible, a player must have a My603Rewards account via the NH Lottery mobile app. Tickets must be entered online through their My603Rewards account on the NH Lottery mobile app, which

is located in both the Apple and Android application stores. **See the Drawing Schedule & Prize Details table on Page 1 for draw schedule.**

Existing My603Rewards or New Hampshire iLottery account holders can log in through the mobile application. New participants must register for a My603Rewards or login using their New Hampshire iLottery account credentials through the mobile application. By successfully transmitting a completed online entry on the mobile app with the appropriate information as directed underneath the \$20 Double Your Million Second Chance Drawing screen, each participant or each eligible ticket will be entered into the Promotion.

Entries of game ticket serial numbers determined to be in an expired, stolen or not part of a valid sold or promotional inventory status are not eligible.

All information submitted online by entrants is subject to, and will be treated in a manner consistent with, the New Hampshire Lottery Commission's (hereinafter, "the Lottery") Privacy Policy, which is currently accessible at: <https://www.nhlottery.com/Privacy-Policy>. The Lottery, at its discretion, reserves the right to select and/or change the prize(s) to be awarded as part of this Promotion. Entrants must be a US Person, 18 years of age or older. Void where prohibited or restricted by law.

#### **RANDOM NUMBER GENERATOR DRAWING AND RESULTS:**

The actual drawing dates will be determined by the Lottery personnel, at the direction of the Executive Director, and the final, verified drawing results will be posted to the mobile application on (or around) a week after the drawing has occurred. The prize winner will be randomly selected from among all eligible entries received. Subject to verification of eligibility and compliance with these Official Rules, the potential winner will be declared the official winner of this Promotion.

#### **GENERAL RULES:**

All prize details, including without limitation, shall be determined in the sole and absolute discretion of the Lottery. The Lottery reserves the right to prosecute and seek damages from any such individual to the fullest extent of the law.

All materials submitted become the property of the Lottery and will not be returned. Prizes are nontransferable to any other person, including relatives or friends. The Lottery or its designee is responsible for supplying the prize awarded, and will provide the winner with a tax form, if applicable.

The Lottery reserves the right to amend the drawing rules as necessary without prior notice no less than ten (10) days before any drawing.

The Lottery offers no warranties or guarantees of product quality and that availability and quality of the prize and its conformance to advertised representations is the sole responsibility of the promotional partner.

CHILD SUPPORT INTERCEPT – Pursuant to RSA 284:21-v, the Lottery is required to review all lottery prize claims subject to federal tax reporting with a child support database provided by the Department of Health and Human Services (DHHS). In the event that a winner of any prize package described above owes child support, the winner shall have up to 21 days from the draw date to settle the total arrearage due as determined by DHHS to the DHHS, after which settlement the winner will be awarded the prize. Failure to settle any arrearage shall result in that winner's prize package being forfeit and the package will be issued to the first available alternate winner. The original winner(s) owing Child Support shall receive no other prize or compensation from the Lottery relating to this game.

## FAQs

### Questions about the Double Your Million Second Chance Drawing

#### Which tickets are eligible for the Double Your Million Second Chance Drawing Promotion?

From **Wednesday, March 29, 2023 at 12:00:00AM – TBD** (the "Promotional Period"), any non-winning and active (meaning it is still eligible for cashing at retail) qualifying scratch tickets may be used to enter the **Double Your Million Second Chance Drawing** ("Promotion"). Eligible scratch tickets are: #1591 (Double Your Million).

#### How do I know if my ticket is eligible?

If you have a non-winning scratch ticket with the game number of #1591 (Double Your Million) that is active (meaning it is still eligible for cashing at retail), that ticket is eligible for entry. Otherwise, a message will appear once a ticket is scanned on the app saying whether it is eligible.

#### What is the promotional period?

The promotional period runs from **Wednesday, March 29, 2023 at 12:00:00AM – TBD**.

#### When is the deadline to enter my ticket(s)?

- **Drawing 1** – All players who have entered at least one ticket into the promotion between March 29, 2023 at 12:00:00AM and December 1, 2024 at 11:59:59PM will automatically be entered to win the prize for Drawing 1.
- **Drawing 2** – All players who have entered at least one ticket into the promotion between March 29, 2023 at 12:00:00AM and **Drawing 2 Date TBD** will automatically be entered to win the prize for Drawing 2.
- **Drawing 3 (Grand Prize)** – All players who have entered at least one ticket into the promotion between March 29, 2023 at 12:00:00AM and **Drawing 3 Date TBD** are eligible to win the prize for Drawing 3.

#### When will the Double Your Million Second Chance Drawing Promotion drawing results be available?

The final verified drawing results will be posted to the NH Lottery mobile application, on (or around) a week after each drawing is conducted.

#### What is the prize for the Double Your Million Second Chance Drawing Promotion?

- **Drawing 1 & 2:**
  - \$10,000. There is NO prize multiplier for Drawing 1 or Drawing 2.
- **Drawing 3 (Grand Prize):**
  - If the non-winning drawn ticket has a 1X in the multiplier box, the player will win \$1 million (\$1,000,000).
  - If the non-winning drawn ticket has a 2X in the multiplier box, the player will win \$2 million (\$2,000,000).

#### Is the Second Chance prize of \$1 million or \$2 million an annuity prize?

No, the Second Chance prize in this drawing is not an annuity prize but is subject to 24% federal tax withholding. The only prizes that are annuity prizes are the instant-win prizes within the Double Your Millions game.

**Am I responsible for any taxes on these prizes?**

Yes. For any prize won via the lottery that is valued at \$600 or greater, it is a taxable prize and it will need to be filed with your federal tax return. The Lottery Commission will withhold federal tax from the prize value at the applicable rate set by the United States Internal Revenue Service, currently 24%.

**Can I enter the Drawings more than one time?**

You can enter up to twenty-five (25) eligible tickets per day, on a rolling time period towards Drawing 3 (Grand Prize). Registered users will receive one (1) entry towards Drawing 3 (Grand Prize) for each eligible Double Your Million (#1591) scratch ticket scanned. For example, a \$20 non-winning Double Your Million (#1591) scratch ticket, will equal one (1) entry towards Drawing 3 (Grand Prize).

The winners for Drawings 1 and 2 will be selected from amongst all the unique players that have entered at least one eligible Double Your Million ticket. Entry for Drawing 1 and 2 is limited to one per player.

**Do I need to keep my tickets after submitting them into the drawings?**

No, you are not required to keep your tickets.

**Can I mail in my entries?**

No, only entries submitted via the NH Lottery mobile app are allowed.

**Am I still eligible to win the grand prize if I win Drawings 1 and/or 2?**

Yes. Winning an earlier drawing does not affect eligibility for future drawings.

**Are my non-winning \$20 Double Your Million (#1591) scratch tickets eligible for My603Rewards points?**

No. During the Second Chance Draw period, eligible non-winning tickets may only be entered for the Second Chance Drawing. Once the deadline has passed for entry into the last drawing, tickets may be eligible for My603Rewards points.
