Tri-State Megabucks Countdown to Summer Second Chance Drawing

PRIZE

- One winner, chosen at random, will receive \$100,000* in the Tri-State Megabucks Countdown to Summer Second Chance Drawing!

*Prize is before taxes are withheld.

OFFICIAL RULES

- From **Monday, June 3, 2024, at 12:00:00AM – Thursday, June 20, 2024, at 11:59:59PM** (the "Promotional Period"), any non-winning and active (meaning it is less than 366 days from date of draw) qualifying New Hampshire Tri-State Megabucks tickets may be used to enter the **Tri-State Megabucks Countdown to Summer Second Chance Drawing** ("The Promotion").
 - **NH iLottery Megabucks purchases are NOT eligible.**
 - Tri-State Megabucks tickets previously entered for My603Rewards points are ineligible for entry.
- Ticket(s) that are eligible for entry are subject to change at the discretion of the New Hampshire Lottery.
- For the dollar value of the non-winning game ticket(s) a player submits, the player will be awarded that many entries into the drawing. The dollar value of the non-winning eligible ticket entered, and the resulting entries awarded are \$1:1.
 - For example, a \$4 non-winning New Hampshire Tri-State Megabucks ticket, will equal four (4) entries.
- Entry is limited to twenty-five (25) total physical tickets entered per person per Second Chance Drawing per day (24-hour period defined as 12:00:00 AM – 11:59:59 PM).
 - For example, a physical non-winning New Hampshire Tri-State Megabucks ticket will count as one (1) of the twenty-five (25) physical tickets towards the daily limit whether it is a single draw or a multi-draw ticket.
 - For a multi-draw ticket (a ticket with multiple draws), a player must wait until the first draw is completed to enter The Promotion.
 - If the first draw on a multi-draw New Hampshire Tri-State Megabucks ticket is non-winning, it can be entered into The Promotion at that time. All draws will be submitted for entries at that time, even if future draws are winners.
 - If the first draw on a multi-draw New Hampshire Tri-State Megabucks ticket is a winner, the ticket cannot be entered into The Promotion and all other lines will not be eligible.
 - However, the Lottery encourages players with multi-draw tickets to request an exchange ticket from their local Lottery retailer after each draw. That way, if the first draw is a winning draw, an exchange ticket can be provided, and the player will have the opportunity to enter The Promotion if subsequent draws are non-winners.
- A player does not need to retain the game ticket(s) they submitted as proof of eligibility to claim their prize if selected as a winner.
- One (1) drawing will be conducted. From all eligible players, the prize will be awarded as follows:

- The final verified drawing results will be posted to NH Lottery mobile app, on (or around) two weeks from the drawing date.
- During The Promotion, New Hampshire Tri-State Megabucks tickets are ineligible to earn My603Rewards Points.
- Tickets entered in The Promotion will be ineligible to earn points.

To be eligible, a player must have a My603Rewards account via the NH Lottery mobile app. Tickets must be entered online through their My603Rewards account on the NH Lottery mobile app, which is located in both the Apple and Android application stores. Deadline for entry is **Thursday, June 20, 2024, at 11:59:59PM** to participate in the drawing.

Existing My603Rewards or New Hampshire iLottery account holders can log in through the mobile application. New participants must register for a My603Rewards or login using their New Hampshire iLottery account credentials through the mobile application. By successfully transmitting a completed online entry on the mobile app with the appropriate information as directed underneath the Tri-State Megabucks Second Chance Drawing screen, each participant or each eligible ticket will be entered into the Promotion.

Entries of game ticket serial numbers determined to be in an expired (older than 366 days of the date of entry), stolen or not part of a valid sold or promotional inventory status are not eligible.

All information submitted online by entrants is subject to, and will be treated in a manner consistent with, the New Hampshire Lottery Commission's (hereinafter, "the Lottery") Privacy Policy, which is currently accessible at: <https://www.nhlottery.com/Privacy-Policy>. The actual drawing date has been determined by the Lottery personnel, at the direction of the Executive Director, and the final, verified drawing results will be posted to the mobile application on (or around) **two weeks from June 26, 2024**. The prize winner will be randomly selected from among all eligible entries received. Subject to verification of eligibility and compliance with these Official Rules, the potential winner will be declared the official winner of this Promotion. There will be one (1) drawing with one (1) winner and five (5) alternates.

FAQs

What is the promotional period?

The promotional period runs from **Monday, June 3, 2024, at 12:00:00AM – Thursday, June 20, 2024, at 11:59:59PM**

When is the deadline to enter my ticket(s)?

All tickets must be entered by **Thursday, June 20, 2024, at 11:59:59PM** to be eligible for The Promotion.

Which tickets are eligible for The Promotion?

Any physical non-winning and active (meaning it is less than 366 days from date of draw) qualifying New Hampshire Tri-State Megabucks tickets, purchased at a retail location may be used to enter The Promotion. If a ticket has previously been entered for My603Rewards points it is NOT eligible.

How do I know if my ticket is eligible?

If you have a non-winning New Hampshire Tri-State Megabucks ticket that is eligible for entry (meaning it is less than 366 days from date of draw) a message will appear once a ticket is scanned on the app saying whether or not it is eligible. NH iLottery (purchased through the NH Lottery website) New Hampshire Tri-State Megabucks purchases are NOT eligible. If a ticket has previously been entered for My603Rewards points it is NOT eligible.

What if I purchased a multi-draw ticket (a ticket with more than one draw)?

Please see the Official Rules section for more information on multi-draw tickets.

When will The Promotion drawing results be available?

The drawing will be conducted, and final verified drawing results will be posted to the mobile application, on (or around) **two weeks from the drawing date.**

What are the prizes for The Promotion?

Please see the Prizes & Drawings section of the rules.

Am I responsible for any taxes on these prizes?

Yes. For any prize won via the Lottery that is valued at \$600 or greater, it is a taxable prize, and it will need to be filed with your federal tax return. Federal taxes estimated at 24% of the value of the prize are the responsibility of the Prizewinner. The Lottery Commission will send winners IRS Forms W-2G in January of the year following the respective receipt of the awarded prize, in this case, January 2026. Additionally, any other taxes or fees not expressly noted, will be the responsibility of the Prizewinner.

Can I enter the drawing more than one time?

Yes. You can enter up to twenty-five (25) eligible physical tickets per Second Chance Drawing per day. Registered users will receive two (2) entries for each \$2 eligible non-winning New Hampshire Tri-State Megabucks ticket scanned. For example, one \$2 non-winning ticket will equal 2 entries.

Do I need to keep my tickets after submitting them into the drawing?

No, you are not required to keep your tickets.

Can I mail in my entries?

No, only entries via the NH Lottery mobile app are allowed.

How do I see how many entries I have?

Go to the "Rewards" section of the NH Lottery app and click on "My Account", then click on "My Drawing Entries." At the top of this page, you will see two tabs, Second Chance Drawing Entries and My603Rewards Entries. Click on "Second Chance Drawing Entries" and find **Tri-State Megabucks Countdown to Summer** on the list. If you do not see **Tri-State Megabucks Countdown to Summer** on the list, you do not have any entries for this Second Chance Drawing.
