

THE NEW HAMPSHIRE LOTTERY COMMISSION® BOSTON RED SOX™ 2018 WORLD SERIES CHAMPIONS™ SCRATCH GAME TICKET SECOND-CHANCE DRAWING RULES

Note: these rules have been revised at the bottom of page 1, to reflect the entry deadline and drawing date & time for the next (third of three), second chance drawing.

- 1. Any non-winning ticket for the \$5 BOSTON RED SOX™ 2018 WORLD SERIES CHAMPIONS™ instant scratch game (game number 1421) may be entered for one of 3 (three) drawings as detailed below.
- 2. To be eligible, the ticket must:
 - Be a non-winning ticket (does not contain any winnable prizes);
 - Have the entrant's name, mailing address, and daytime phone number legibly printed in the space provided on the back of the ticket. A mailing label is also acceptable;
 - Be signed by the entrant in the space provided on the back of the ticket;
 - Not be creased, folded or otherwise damaged, or altered in any way to give it an unfair advantage in the drawings. Note, multiple entries may be submitted in the same envelope; and

- 3. There will be three drawings total, held at New Hampshire Lottery Commission (NH Lottery) headquarters.
- 4. Eligible entries must be received by 4:00PM EST on the entry deadline date (below). Tickets received after the deadline will be entered into the next available drawing; tickets received after 4:00PM on the date to be announced for the final of three drawings will be set aside for destruction.

- 5. Entries are good for one drawing only. Tickets not drawn for a prize at any drawing will be removed for destruction prior to any subsequent drawing.
- 6. For the first drawing, the prizes will be awarded in the following order:
 - Twenty (20) 2019 Boston Red Sox® Regular Season Home Game Grandstand Ticket Packages
 - Two (2) 2020 Home Game Legends Suite Packages
- 7. For the second drawing, the prizes will be awarded in the following order:
 - Five (5) 2020 Home Game Legends Suite Packages
 - Ten (10) 2020 Boston Red Sox® Regular Season Home Game Grandstand Ticket Packages
- 8. For the third drawing, the prizes will be awarded in the following order:
 - Eight (8) 2020 Home Game Legends Suite Packages
 - Ten (10) 2020 Boston Red Sox® Regular Season Home Game Grandstand Ticket Packages
- 9. Each Regular Season Home Game Grandstand Ticket Package includes:
 - Two (2) 2019 or 2020 Boston Red Sox® Regular Season Home Game Grandstand tickets and \$150 spending money
- 10. Each Regular Season Home Game Legends Suite Package includes:
 - Four (4) 2020 Boston Red Sox® Regular Season Home Game Legends Suite tickets and \$250 spending money
 - An appearance by David Ortiz in each suite, based on availability.
 - Pre-game, guided behind the scenes tour of Fenway Park™
 - On-field viewing access from areas of the infield warning track designated by the Boston Red Sox® during batting practice
 - Two (2) dedicated Boston Red Sox® Hosts
- 11. At the conclusion of each drawing described above, five (5) alternate tickets will be drawn.
- 12. No person may win more than one (1) prize per drawing date. In the event that two or more tickets are drawn with the same entrant's name, only the first ticket drawn will be eligible to win a prize; the subsequent ticket(s) will be discarded and another will be drawn in its place.
- 13. \$5 BOSTON RED SOX™ 2018 WORLD SERIES CHAMPIONS™ instant scratch game may continue to be sold after the final drawing.
- 14. Federal taxes estimated at 24% of the value of each package that is valued at \$600 or greater will be borne by the NH Lottery. The NH Lottery's vendor, MDi will send winners IRS Forms 1099 in January of the year following the respective usage of the awarded prize. Any other taxes or fees will be the responsibility of the prize winners. MDi will also be responsible for prize fulfillment.
- 15. The prizes will be as described above and there will be no substitution by cash.
- 16. MDi or the Boston Red Sox® may substitute a prize of equal or higher value upon prior written notification to, and prior written approval from, the NH Lottery.

- 17. Game tickets will be for games determined by the Boston Red Sox® only and cannot be exchanged for different games.
- 18. Winners will be notified by mail, e-mail or telephone, using the contact information on the drawn tickets, and claim form.
- 19. To claim a prize, each winner shall complete a NH Lottery Prize Claim Form and return same within 30 (thirty) days* of the forms being mailed from the NH Lottery. Failure to comply will result in the prize package being forfeited and the prize will be awarded to the first available alternate winner. Once the NH Lottery Prize Claim Form is received by the NH Lottery, the winner's information will be sent to MDi to start the prize fulfillment process.
- 20. *NOTE: If a game is scheduled to be held within the 30 days noted above, then the winner will be allowed only 14 days to submit all required paperwork. The NH Lottery reserves the right to amend the drawing rules as necessary without prior notice no less than 10 (ten) days before any drawing.
- 21. The NH Lottery offers no warrantees or guarantees of product quality and that availability and quality of the prize and its conformance to advertised representations is the sole responsibility of the promotional partner.
- 22. The NH Lottery shall not be responsible for any prizes lost, damaged or stolen during shipment, pickup or use.
- 23. The NH Lottery shall not be responsible for injury or loss of life resulting from any prize awarded.
- 24. Participants release and hold harmless the Commission and its agents and employees from any liability arising out of participation in the drawings. The Commission is not responsible for any negligence of any person, or any claim, liability, injury, property loss, or other loss to participants or their companions arising from or in connection with any event or occurrence related to these drawing.
- 25. The Commission, at their sole discretion, may disqualify an entry, winner, or designee from participating in any aspect of the drawing if they deem or suspect that such person has engaged in or has attempted to engage in any of the following:
 - Act in violation of these Official Rules, Terms of Use, or Privacy Statement;
 - Act with intent to annoy, harass or abuse any other person;
 - Behave in any unsportsmanlike, inappropriate, uncooperative, disruptive, fraudulent, potentially fraudulent, or unusual behavior or activity; or

26. <u>CHILD SUPPORT INTERCEPT</u> — Pursuant to RSA 284:21-v, the NH Lottery is required to review all lottery prize claims subject to federal tax reporting with a child support database provided by the Department of Health and Human Services (DHHS). In the event that a winner of any prize package described above owes child support, the winner shall have up to 21 days from the draw date to settle the total arrearage due as determined by DHHS to the DHHS, after which settlement the winner will be awarded the prize. Failure to settle any arrearage shall result in that winner's prize package being forfeit and the package will be issued to the first available alternate winner. The original winner(s) owing Child Support shall receive no other prize or compensation from the NH Lottery relating to this game.
